The organizer shall, as soon as possible after the last entry date, and **no later than** 12 days before the dog show, inform the judge in writing of the number of dogs of each breed. Dogs/breeds must not be transferred without the individual judges being consulted prior to the transfer.

A judging appointment can only be cancelled for **extremely** serious reasons (illness, excessively low entry figures etc.) This condition applies to organizers as well as to judges. In all other respects, organizers and judges are obliged to observe the regulations for dog shows and judging appointments published by the Svenska Kennelklubben. In accordance with the general instructions in the regulations regarding judging ethics adopted by the Svenska Kennelklubben, judges must avoid judging the same breed in too close proximity to the location and date of the show covered by this agreement; • not judge the same breed/breeds too close in time and place in Sweden • judging by the BSI's intentions • judging by the SKK's show rules • judging by the FCI's breed standards • follow the SKK's code of ethics for judges, the FCI's Code of Commitments and FCI's Regulations for show Judges. *More information at www.skk.se/en/Dog-shows/Judging-in-Sweden*
